## CalChamber Urging Veto of 'Job Killer' Proposals

*Opposition Stops Many 'Job Killers' for Now*



Before legislators adjourned their regular session on September 12, they sent 12 California Chamber of Commerce-opposed "job killer" bills to the Governor for consideration.

The CalChamber will be asking the Governor to veto these proposals and is urging employers to send their veto requests to the Governor as well.

Amendments made in the closing days of the regular session reduced the impact of several "job killers." Action on others has been delayed until the next session.

As the result of negotiations, legislation that originally would have rolled back cost-saving workers' compensation reforms now resolves a problem with current law and the CalChamber is urging support for the bill (see story below).

### Seeking Veto

The CalChamber is asking the Governor to **veto** the following "job killer" bills: **Barriers to Affordable Housing**

● **AB 35 (Ruskin; D-Redwood City) Increased Construction Costs.** Establishes an isolated process by which a minimum level of "green building" standards are set by a private entity, thereby

## Negotiations Turn Former 'Job Killer' Bill into Solution for a Workers' Comp Problem



### SUPPORT

A former California Chamber of Commerce-opposed "job killer" bill that would have undermined workers' compensation reforms has been amended to bring the

CalChamber in **support**.

**AB 338 (Coto; D-San Jose)** has passed the Legislature and awaits action by Governor Arnold Schwarzenegger. The current version of the bill is the product of affected stakeholders and legislators working together to create an unquestionably reasonable approach

to resolving issues within the workers' compensation system.

AB 338 now resolves a problem in current law relating to the 104-week cap on temporary disability benefits by amending the "window" in which injured workers are eligible for benefits. The CalChamber believes that AB 338 represents a balanced approach to resolving a real and tangible problem in the workers' compensation system.

Before the amendments, AB 338 would have increased temporary disability costs in workers' compensation claims by increasing the number of weeks

# No Right to Terminate Employees Solely for Sex Offender Registration

*Can I terminate an employee for being on Megan's List?*

In California, convicted sex offenders are required to register their place of residence and any changes they make for the rest of their life. This information is available to the public under a registry known as Megan's List.

### Protections in Law

While the addresses are available, employers may not be able to use that information to terminate employment due to the protections granted under Penal Code Section 290.46.

The relevant portion quoted below prevents an employer from using that information for employment purposes:

*(2) Except as authorized under paragraph (1) or any other provision of law, use of any information that is disclosed pursuant to this section for purposes relating to any of the following is prohibited:*

*(A) Health insurance.*

*(B) Insurance.*

*(C) Loans.*

*(D) Credit.*

*(E) Employment.*

*(F) Education, scholarships, or fellowships.*

*(G) Housing or accommodations.*

*(H) Benefits, privileges, or services provided by any business establishment.*

### Factors to Consider

Given this protection, it is essential that an employer evaluate the applicant or employee in light of the realities of the

workplace. Factors to consider include:

- the business that the employer is in, that is, child care or preschool;

- whether the employee may be working where children may be present, that is, service work performed in customer homes;

- whether the employee will be working independently or unsupervised;

- whether the employee will be in a trusted position such as security or maintenance.

For example, if an applicant was convicted of child molestation, a preschool would not be able to place that person in a position involving children. Likewise, an applicant applying for a janitorial or security guard position may pose a greater security risk if children are present.

## Economic Advisory Council Special Report Available on CalChamber Website

The U.S. economy has continued to demonstrate resilience in the face of high energy prices and persistent housing market weakness, while California is underperforming the U.S. labor market, according to the latest quarterly report of the California Chamber of Commerce Economic Advisory Council.

In its third quarter report, the council noted that the education, health services and leisure and hospitality sectors are dominating job growth, while weakness in the construction, real estate and technology industries has left the state trailing the nation's labor market.

Although the falloff in home construction was large, it was substantially tamer than the decline in the prior four quarters.

However, the downturn in homebuilding appears to be re-accelerating in response to tighter lending standards, and the council cited continued problems in the housing market as a contributor to the broader economic slowdown.

## CalChamber Applauds Governor's Comprehensive Water Approach

The California Chamber of Commerce this week praised Governor Arnold Schwarzenegger's efforts to develop a comprehensive water plan.

The Governor's \$9 billion comprehensive water infrastructure proposal will be introduced in the legislative special session that he called in response to California's water crisis.

"The CalChamber applauds the Governor's efforts to solve California's long-neglected water crisis," said CalChamber President Allan Zaremberg. "The water system that contributed to California's emergence as one of the world's major economic powers is faltering. Existing facilities are barely able to meet current public demand."

### Substantial Investment

"California's economy and environmental protections require a substantial investment in our water infrastructure. The Governor's leadership to enhance our

water supply and protect the Delta — the source of water for half of California — from earthquakes and other natural disasters is critical to California's future. A reliable source of safe drinking water will be in jeopardy if we don't adopt the Governor's proposal to add water supply and ensure water conveyance through the Delta," Zaremberg said.

The plan invests \$600 million from Propositions 50, 84 and 1E to immediately relieve pressure on the Delta from environmental challenges and to respond to a recent federal court ruling that will reduce water deliveries to Southern California. It also includes \$5.6 billion for water storage, nearly \$2 billion for Delta restoration (in addition to the above-mentioned \$600 million), \$1 billion in grants for conservation and regional water projects and \$500 million for specific water restoration projects.

Written in two bills authored by Assembly Republican Leader Michael

Villines (R-Fresno) and Senator Dave Cogdill (R-Modesto), the proposal represents a combination of ideas previously detailed in proposals by the Governor and legislative leaders.

### Comprehensive Package Needed

"The Legislature owes Californians a comprehensive water package that invests in its future and finances infrastructure projects for surface and groundwater storage, water use efficiency, environmental restoration and water quality projects in the state," Zaremberg said.

"The CalChamber will continue to work with the Legislature, Governor Schwarzenegger and other interested parties to ensure that the state has sufficient facilities to capture, retain and convey the water needed to support California's growing population and economy. California can't afford to settle for anything less," he said.

excluding any public review or input. The measure also creates conflicts and confusion with existing and proposed building codes.

● **AB 888 (Lieu; D-Torrance) Increased Construction Costs.** Makes it extremely difficult for small businesses to compete by establishing an arbitrary definition of “commercial.” The bill also creates conflicts and confusion with existing and proposed building codes and establishes an isolated process by which a minimum level of “green building” standards are set by a private entity, thereby excluding any public review or input.

● **AB 1058 (Laird; D-Santa Cruz) Increased Construction Costs.** Adds significant costs to housing purchase as well as rental affordability by requiring the Department of Housing and Community Development to use the most stringent provisions of five sets of national “green building” guidelines as a basis for developing California’s mandatory “green building” standards. The bill also causes confusion by establishing a multiple-state agency quasi-regulatory authority for developing “green building” standards.

### **Costly Workplace Mandates**

● **AB 8 (Núñez; D-Los Angeles) Health Care Tax on Employers.** Imposes a tax on small employers who can’t afford to provide health care coverage, to fund health care coverage for those who don’t currently purchase it.

● **AB 504 (Swanson; D-Oakland) Mandatory Payments for Striking Employees.** Forces employers to pay striking employees by creating a new definition of lockout that requires an employer to pay restitution to employees.

● **SB 180 (Migden; D-San Francisco)/ SB 650 (Migden; D-San Francisco) Increased Agricultural Costs.** Hurts competitiveness of California agriculture producers, driving businesses out of state, killing jobs and increasing loss of farmland, by artificially increasing labor costs for California producers who must compete in a global market with lower-than-average operating costs; removes secret ballot election requirement for union representation and prohibits employer communication with employees. SB 650 sunsets after five years.

● **SB 622 (Padilla; D-Pacoima) Independent Contractors.** Creates a

new excuse to sue employers and exposes them to excessive new penalties for “willful misclassification” of independent contractors without providing a clear roadmap for employers to comply.

### ● **SB 936 (Perata; D-Oakland) Roll Back of Cost-Saving Workers’ Compensation Reforms.**

Increases the cost of hiring and keeping employees by rolling back historic reforms and doubling permanent disability costs in California’s workers’ compensation system.

### ● **SB 942 (Migden; D-San Francisco) Increased Workers’ Compensation Costs.**

Alters the rules for return-to-work and the provision of Supplemental Job Displacement Voucher benefits in workers’ compensation to require that employers provide the injured worker with a job voucher before they know the amount of the benefit that is due to the injured worker, and provides no avenue to recoup costs if the benefit provided was more than that to which the injured worker was actually entitled.

### **Fuel Price Increases**

● **SB 210 (Kehoe; D-San Diego) Restrictive Fuel Standard.** Interferes with the development of a competitive alternative fuels market and threatens job creation in California by creating a costly Low Carbon Fuel Standard that conflicts with the existing standard created by Governor’s Executive Order S-7-04.

### **Inflated Liability Costs**

● **SB 93 (Corbett; D-San Leandro) Inflated Liability Costs.** Artificially inflates medical damage awards in third party liability cases by not allowing judges to consider the actual cost of medical expenses as evidence, ultimately increasing, not only legal costs, but also rates for auto and general liability insurance.

### **Amended**

● **AB 5 (Wolk; D-Davis) Housing Development Restrictions.** Following amendments, the CalChamber is **neutral** on this former “job killer.”

● **AB 70 (Jones; D-Sacramento) Housing Development Restrictions.** No longer a “job killer,” but still **opposed** by

the CalChamber, the bill slows development of housing. The CalChamber is asking the Governor to veto this bill.

### **Stopped for Now**

Further action has been delayed until next year on bills that increase employer liability exposure - **AB 437 (Jones; D-Sacramento)**; legislate a new fuel mandate - **SB 140 (Kehoe; D-San Diego)** and tax freight movement - **SB 974 (Lowenthal; D-Long Beach).**

# California Chamber Status Report on Major Legislation for Business

The following list summarizes top priority bills for the California Chamber of Commerce and their status as of September 12, when the Legislature adjourned its regular session.

Within each subject area, the list presents bills in order of priority, with the highest priorities at the top.

In October, the CalChamber will publish the final status report on priority bills, showing the ultimate fate of legislation sent to the Governor this year.

October 14 is the last day for the Governor to sign or veto bills passed by the Legislature before it began its interim recess.

Each fall, the CalChamber also publishes a record of legislators' votes on key bills affecting California's business climate. Generally, the bills selected for the vote record have appeared in one of the status reports. This year's vote record will be published on November 2.

Federal bills are marked with an \*.

# CalChamber Offers Look at India, Mexico

## Trade Official Highlights Long-Term Potential in India

An international luncheon forum hosted by the California Chamber of Commerce on September 5 provided an opportunity to learn more about trade and investment opportunities in India from Ambassador Douglas A. Hartwick, assistant U.S. trade representative.

Among the more than 65 guests were California government officials and businesspeople from California, including representatives of agriculture, manufacturing and technology.

Hartwick commented that India offers U.S. businesses a lot of opportunities to succeed, especially since the late 1990s. Reforms in the 1990s included the simplification of the tax structure, abolishing import licenses and lowering tariffs. These reforms and more helped bring worldwide investment in India from \$100 million in 1990 to top \$11 billion in 2006.

The United States and India are the world's largest democracies and share a common interest in the free flow of commerce and resources.

The United States is India's leading trade and investment partner, Hartwick said. "We would like to double trade with

India by 2008 to \$60 billion per year. With the Indian economy growing at nine-plus percent per year, that is a lot of opportunity, that's a lot of potential trade and we need to be a part of that."

### Opportunities for California

India is the 17th largest export market for California, which exported \$1.7 billion worth of goods to India in 2006.

The top four major items of export from California to India are: computers and electronic products, transportation equipment, manufactured goods and agricultural products. Computers and electronic products make up more than 30 percent of total California exports to India. California exports of these items grew from \$1.3 billion in 2005 to \$1.6 billion in 2006.

India offers California three strong areas to engage in: information technology, agriculture development and defense trade.

### Trade Mission Postponed

Governor Arnold Schwarzenegger has postponed the trade mission to India until

## Ambassador to Mexico Urges Building on Success of NAFTA

The solution to maximizing economic success between Mexico and the United States is building on the North American Free Trade Agreement (NAFTA), said His Excellency Arturo Sarukhan, Mexican Ambassador to the United States, at a California Chamber of Commerce international luncheon forum on September 12.

Among the 75 guests were government officials and businesspeople from California, including Lieutenant Governor John Garamendi and representatives from agriculture, manufacturing, technology and international relations.

Ambassador Sarukhan commented that "there are few relationships as strategic in nature as the relationship between Mexico and the United States."

### Support for NAFTA

The ambassador lauded the success of

NAFTA, and said it is time to build upon that success.

"As a result of NAFTA, trade from Mexico to the United States tripled in 10 years," Sarukhan said. "Now we are the third-largest trading partner of the United States, and that speaks volumes about some of the challenges that we face as we compete with India and China and others on the world stage."

He said Mexico has become the largest market for California exports.

He also credited NAFTA with the resurgence of a middle class sector in Mexico, a piece of the economy he said had been missing since the 1970s.

"I think the fact that Mexico has had the ability to sustain macroeconomic stability, and for the first time re-create an urban, suburban, middle class, middle income sector, is one of the largest success

stories of NAFTA," he said.

NAFTA also made Mexico a much more open country to the world and led to the economic achievements of the avocado industry, Sarukhan said.

He said that avocados are one of the huge success stories of economic growth and job creation in Mexico, as well as of the opportunities that the free trade agreement opened up for the agricultural business in both countries to complement each other in its seasons and its produce.

"I think the solution is more NAFTA, not less NAFTA," Sarukhan said.

### Mexican-U.S. Labor

Sarukhan also identified labor mobility as a key issue between the two nations. "At the end of the day, comprehensive immigration reform in the United States

## U.S.-Peru Trade Agreement Needs Support



The California Chamber of Commerce is urging its members to ask their representatives in Congress to **support** the U.S.-Peru Free Trade Agreement (FTA), which is expected to be voted on in early October.

Agreements like the proposed U.S.-Peru FTA ensure that the United States may continue to gain access to world markets, which will result in an improved economy and additional employment of Americans.

President Bush formally notified the U.S. Congress of his intent to sign the U.S.-Peru FTA in January 2006 in accordance with trade negotiating timelines.

In June 2006 the Peruvian Congress overwhelmingly approved the agreement by a vote of 79-14 with six abstentions.

### Dynamic Peruvian Economy

Peru, approximately three times the size of California, is the third largest country in South America. Peru is the fifth most populous country in Latin America, and has an annual gross domestic product (GDP) of more than \$67 billion.

Peru's economy is one of the most dynamic in Latin America, showing particularly strong growth over the last three years. Recent economic expansion has been driven by construction, mining, investment, domestic demand and exports.

Total trade in 2006 between Peru and the United States was more than \$8 billion, with the United States exporting \$2.9 billion worth of goods to the nation. About 200,000 U.S. citizens visit Peru annually for business, tourism and study. Nearly 16,000 Americans reside in Peru, and more than 400 companies are represented in the country.

In 2006, California exported \$180 million to Peru, making it one of the state's 50 largest trading partners.

### Action Needed

The CalChamber, in keeping with long-standing policy, enthusiastically supports free trade worldwide, expansion of international trade and investment, fair and equitable market access for California products abroad and elimination of disincentives that impede the international competitiveness of California business. New multilateral, sectoral and regional trade agreements ensure that the United

will have to start in Mexico. We will have to prove that we have the ability to generate the well-paying jobs and economic growth so that 400,000 Mexicans a year do not have to cross the border in search of a better life."

He said Mexico could not plot out a route to economic prosperity if it loses much of its talented workforce to the United States.

Mexican demographics are changing dramatically, he said, and in coming decades, "there simply won't be enough Mexicans to pump the Mexican economy and at the same time to cross the borders and help the vineyards and the orchards of America."

## Negotiations Turn Former ‘Job Killer’ into Workers’ Comp Solution

benefits can be paid and by creating a disincentive to use utilization review to enforce medical treatment guidelines.

### Fix to Current Law

Due to an unintended interpretation of current law, the 104-week cap serves as a disincentive to return to work and may financially harm legitimately injured workers.

The interpretation is that the current cap creates a 104-week window in which injured workers are eligible for temporary disability benefits. Under this interpretation, an injured worker could return to work after even one day of payable temporary disability and that injured worker’s eligibility to receive benefits under the cap would continue to decrease.

AB 338 instead states that an injured

worker is eligible to receive 104 weeks of temporary disability within five years of the date of injury.

The solution under AB 338 promotes return to work in an equitable way by allowing 104 weeks of aggregate benefits within five years of the date of injury. This gives injured workers adequate time to obtain needed treatment, including surgery, and return to work after recovery.

However, this approach maintains the 104-week cap that has proven to be vitally important in speeding the claims process and improving return-to-work rates.

AB 338 also addresses an issue presented by *Valeri Hawkins v. Amberwood Products and SCIF*, a recent court case that would result in an employer owing more than 104 weeks of temporary disability payments under some circumstances. In this case the court found that

the 104-week cap applied only to benefits after the date the first payment was made.

This case could provide a disincentive to contest questionable claims — if an employer contests a claim and the issue is not adjudicated for one year, the employer would be liable for a full year of temporary disability outside of the 104-week cap.

AB 338 would reverse the judicial weakening of the cap and make it so employers are not punished for contesting questionable claims.

### Action Needed

The CalChamber is urging employers to ask Governor Schwarzenegger to **sign AB 338**.
