Dear Speaker Boehner, Leader Reid, Leader Pelosi and Leader McConnell:

As companies and associations with an interest in the Generalized System of Preferences (GSP) trade program, we are writing to urge retroactive GSP renewal before the end of the year.

First enacted in 1974, GSP eliminates import taxes on certain products from approximately 130 developing countries. The current GSP expiration, now in its 16th month, is the longest in GSP's 40-year history. Since GSP expired on July 31, 2013, American companies like ours have paid more than \$850 million in higher taxes. If GSP is not renewed during the 113th Congress, the tax hike on American companies will exceed \$1 billion.

This is having a severe impact on our companies and workers. To compensate for higher taxes, some of us have been forced to lay off workers, delay new hires, cut worker benefits, and cancel job-creating investments while awaiting congressional action. Multiple companies who would otherwise have joined us in signing this letter could not, because they have gone out of business as a result of the higher costs associated with GSP expiration.

We represent single-person sole proprietorships as well as some of the largest corporations in the world. The vast majority of us are small businesses that can least afford the nearly \$2 million per day cost of GSP expiration. We are also geographically diverse. The signatories on this letter are headquartered in 45 states and 282 congressional districts, the District of Columbia, and Puerto Rico. We operate in every state and congressional district.

A retroactive GSP renewal would refund hundreds of millions of dollars in taxes paid to companies throughout the United States. Instead of struggling to stay in business, we could hire new workers, increase benefits for existing employees, and invest in future growth.

We look forward to working with you and your colleagues to renew GSP before the end of this session of Congress.
