Advocacy Return on Investment

Quadrupling limit on medical malpractice awards: higher costs and lawsuits stopped (Proposition 46)	\$9.9 Billion
Investment in critical water infrastructure (Proposition 1)	\$7.5 Billion
Limit on in-state energy development: tax revenue at risk saved (fracking moratorium: SB 1132, AB 2420)	\$6.7 Billion

Expansion of product defect litigation stopped (SB 1188)	\$1 million per class action lawsuit avoided
Workers' compensation presumption expansion stopped (AB 2616)	Up to \$200,000 per claim
Minimum wage indexing stopped (SB 935)	\$6,000 per hourly employee/ \$15,000 per exempt employee
Unproven pre-judgment wage liens stopped (AB 2416)	\$70,000 per lawsuit
Expansion of discrimination litigation, new health care coverage penalties stopped (AB 880)	\$70,000 per lawsuit avoided
Expanded litigation for franchisors vetoed (SB 610)	\$70,000 per lawsuit stopped
California-only food labeling stopped (SB 1040/SB 1381)	\$400/year additional cost per family
