Dear Sir/Madam,

On February 24, 2022, Russia announced the start of military aggression against Ukraine. This is an act of war, an attack on the sovereignty and territorial integrity of Ukraine, a brutal violation of the UN Charter and basic norms and principles of international law.

As a result of the mass bombing of Ukraine with all types of anti-aircraft and missile weapons, including multiple-launch rocket systems, with the support of fighter jets, bomber aircraft and drones, intervening columns of tanks, armored personnel carriers, and heavy artillery across the Ukrainian border, the Russian rockets and bombs attack and kill Ukrainian civilians and children, bombing maternity hospitals, orphanages, schools, kindergartens.

More than 9 million Ukrainians were forced to leave their homes, and those who stayed in the cities, which are under siege by Russian troops, face a humanitarian catastrophe, deliberately created by Russia.

The Government of Ukraine calls on international partners, investors, NGOs, businesses and citizens to provide financial support to Ukraine, thereby helping to restore the stability of the Ukrainian economy and support Ukrainians in the war against Russia (<https://www.kmu.gov.ua/gromadskosti/fondi-vidnovlennya-ukrayini>).

The proceeds will be distributed according to the specializations of the fund. These include supporting the Ukrainian army and providing humanitarian assistance to the victims, rebuilding destroyed infrastructure and transforming the economy, restoring small and medium-sized businesses and servicing Ukraine's international financial obligations.

Financial assistance can be transferred to separate official accounts of the recovery funds in UAH, USD, EUR and GBP.
