The event connects U.S. government, industry and international partners to share knowledge, identify export opportunities in emerging Indo-Pacific economies, and help partners find infrastructure solutions for development challenges. The agenda focuses on the latest developments impacting key sectors, as well as discussion of policy recommendations and new opportunities for expanded public-private partnerships. The event is also a chance to learn more about U.S. Government tools and programs to support U.S. projects in the region.
